TASK FORCE 81 (OP WĀTEA) - SITREP 40/10

J1. Personnel Matters

TF81 continues to focus on operations with the Ministry of Interior (MOI) for short notice tasks in support of CRU through the disruption of insurgent movement, leadership and supply throughout Kabul and its surrounding provinces. They are not set up to receive cash payments. It is there understanding that there is a Nation to Nation / Force to Force agreement and that the accounts are paid through this process. S9 will hold the accounts for future reference if required.

Command Comment

15. TF81 is undergoing a busy period currently. Op tempo remains high with a number of jobs being conducted over the RIP period. This has the benefit of allowing the new command team to be involved in the planning and execution of these

missions. The Handover taker over (HOTO) program has commenced yesterday and will be complete for transfer of authority on 06 Oct. Planning for the CPP task in support of CDF and MINPOL visit period 06-10 Oct continues.

16. TF81 and CRU disrupted INS plans to attack the NZPRT over their RIP period last night. This task has taken considerable effort to organise from a theatre perspective. In the eventuality, there were multiple decision briefs at multiple levels across ISAF and GIRoA to get the mission accomplished. Any one of these decision thresholds could have stopped the mission going ahead. Support from COMISAFSOF PSR(IC)3, PSR(Sen)1 and the relationships that Op Wātea 2 has built up over their tour were instrumental in getting a green light PSR(S)1

TF81 will monitor the

PSR(S)2, PSR(S)3 from this mission and will remain prepared to support the NZPRT in the future.

INTELLIGENCE SUMMARY TF81-051 3 OCT 2010

SUMMARY OF THREAT ACTIVITY OVER PERIOD 27 SEP - 03 OCT 10.

- 1. (ISAF SECRET)—Uncorroborated reporting this week indicates INS planning to conduct attacks against various CF compounds including Camp WAREHOUSE as well as United Nations compounds.
- 2. (ISAF SECRET) S2 COMMENT: It is assessed IDF threats continue to be the most likely insurgent method of attack based on recent attacks. However, there will likely be increased indications of INS planning over the coming weeks as INS commanders come under greater pressure to attack prominent GIRoA, ISAF, and international targets to mitigate poor performance and generate propaganda that discredits GIRoA/ISAF security effectiveness. END COMMENT.

AO REPORTING

3. (ISAF SECRET) KABUL CITY PDs 2, 5, 8 and 9 are assessed as posing a HIGH level of threat to ISAF forces (CW sits on the boundary of PD 9). ISAF define a HIGH threat as:

- 5. (ISAF SECRET) Specific threats to TF81 and Camp Warehouse (Kabul): Generic IDF threat against various international targets including Camp Warehouse.
- 6. (ISAF SECRET) ANSF capacity and effectiveness in TF81 AIR: NSTR
- 7. (ISAF SECRET) ISAF capacity and effectiveness in TF81 AIR: NSTR.
