<p>1. ANSF confirmed that PSR(Sen)1, PSR(IC)3 has handed in one AK-47 and received AFG\$5,000 (approx US\$100) and a certificate. ANSF says that PSR(Sen)1, PSR(IC)3 is expecting more money but unknown how much.</p> <p>2. ANSF was advised of the reintegration initiative which won't start until May 10 (after the Peace Jirga 28/29 Apr 10) and the issues in the interim.</p> <p>3. ANSF believes the there will be problems when PSR(sen)1 MERAJ return to ANADARAH. This is due to previous issues between these people and PSR(Sen)1 He says MERAJ moved to PAKISTAN due to family issues. And if the NZPRT provokes PSR(Sen)1 then there is the potential to lose a support base through a group of people particularly in GARDENDEH and TALA-WA BARFAK. As PSR(Sen)1 is connected to PSR(Sen)1 who in turn is connected to Qari MUSA. Although lately, it appears that PSR(Sen)1 has isolated MUSA from himself. As this involves a lot of influential and key people, ANSF says this could be bad for the NZPRT.</p> <p>4. ANSF has not met with PSR(Sen)1 yet.</p> <p>5. PSR(Sen)1 was informed after the meeting (22 Mar 10) that PSR(Sen)1 and PSR(Sen)1 would be arriving today to discuss the SANGPAR ANP CP and that PSR(Sen)1 would like to be in command of it. PSR(Sen)1 needed to be reminded of who these people were. The SNO stated that all avenues have been exhausted in trying to bring Malauwi NEMATULLAH and Comd ABDULLAH in for dialogue. <b>S2 COMMENT:</b> Malauwi NEMATULLAH and Comd ABDULLAH, aka KALTA, are relatives of PSR(Sen)1 stated that PSR(Sen)1 is very influential in the area surrounding GARDENDEH, includes TIRGIRAN, and that nothing would happen while he is in command of the SANGPAR ANP CP. <b>END COMMENT.</b></p> <p>6. WRT to the attack on LBG on 22 Mar 10, ANSF believes this attack occurred to stop Malauwi NEMATULLAH and Comd ABDULLAH from attending the meeting in SEYA LAYAK. He insinuated that this attack was facilitated through PSR(Sen)1 and PSR(Sen)1 as they are the type of people that would do this kind of act. ANSF was unsure if MUSA was involved. ANSF was informed that PSR(Sen)1</p> <p>7. ANSF believes that if we can cut the INS lines of communication then we would succeed in stopping INS activity. He said the TB need a road to the north of AFGHANISTAN IOT be supported as now the weather is warming up, the TB can use transport to move money, personnel and weapons. 8. <b>ANSF</b> recommends the ANP CP at the SHIBAR Pass is complete. It only has two containers, needs a kitchen and a water tank. <b>S2 COMMENT:</b> KT3 conducted a patrol to the SHIBAR PASS ANP CP on Friday, 06 Nov 09. They reported the CP as being 'set up ready to go surrounded by filled HESCO but unoccupied as it had just been built. They also said it was on high ground with good all round observation, no villages in the immediate proximity, a number of alternative routes to the south which could support criminal activity such as smuggling and be used to bypass this CP. <b>END COMMENT.</b>
