PSR(Sen)1, PSR(IC)3 was contacted by PSR(Sen)1 IOT have a meeting to discuss the security issues in the SANPAR area. PSR(Sen)1 and ANSF attended the meeting with ANSF doing the majority of the talking.

PSR(Sen)1 started the meeting by referring to 2 c aches that he had been told about that are in the SHIBAR area. No other info was provided by PSR(Sen)1, he said he would contact PSR(Sen)1 when he had more info. (NZPRT EOD Rep has been warned out).

ANSF raised the issue of the SANGPAR robberies and murders. NDS know who did it (are doing it) but are meeting with the PG this morning (20 Jan 2010) to ask for further direction. S2 COMMENT: Given the NDS have a mandate to deal with people within the AO, it is possible that they will be requesting permission to conduct operations across the border into the GARDANDEH valley where many reports have indicated the presence of the bandits. It is also possible that they have obtained the name of a significant figure who is reportedly involved and need permission from the PG to pursue an investigation. END COMMENT.

ANSF stated that the group operating in SANGAR consists of 8 pers. Some of them live in GARDANDEH Valley and the remainder live close to the SANGPAR area in places such as BAGHAK. The group from SANGPAR are responsible for watching the PRT patrols. Once the patrols have gone, the informants deploy their lookouts around the area and then let the GARDANDEH group know that everything has been set up. The GARDANDEH group then moves into the SANGPAR area to conduct their activities. This group buries weapons in the area (unsure when this is done i.e. how long prior to operations) then uplifts them immediately prior to conducting their operations. They use safe houses to transit through and to wait for the moment to conduct their operations. NFI.

Also, ANSF named Abdullah KALTA as the commander of the group(s) that attacked NZPRT elms at DO ABE CP in Aug 09 and at SANPAR in early Nov 09. He lives in TIGRAN in TALA-WA BARFEK and works for NEMATULLAH and QARI MUSA. NFI. S2 COMMENT: Both NEMATULLAH and MUSA have been identified as likely replacements for PSR(Sen)1 to conduct INS activity in Eastern BAMYAN Province. COMMENT ENDS.
